

Car Seat Giveaway Terms and Conditions

1. **Eligibility:** The Car Seat Giveaway is open to legal residents of Louisiana. Employees, officers, directors, agents, and representatives of Dudley DeBosier Injury Lawyers (“Administrator”), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, the “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside Louisiana and where prohibited by law. All applicable federal, state, and local laws apply.
2. **Promotion Period:** Sweepstakes begins on 9/11/2020 and ends on 9/23/2020 (“Promotion Period”).

Each car seat meets or exceeds all applicable Federal safety standards and Evenflo's side impact standard. Dudley DeBosier is not responsible for any car seat after it has left the office. Each winner will be expected to pick up their car seat from their nearest Dudley DeBosier office location the week of 9/28/2020.
3. **Miscellaneous:** No transfer, assignment, cash redemption, or substitution of prize (or portion thereof) except by Sponsor, who reserves the right to substitute a prize(s) with one of comparable or greater value (except as otherwise provided above), at its sole discretion. Non-compliance with the foregoing, with these Official Rules, or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner.
